

"Marc H. Morial, president and CEO of the National Ur-

ban League; Melanie Campbell, president and CEO of the National Coalition on Black Civic Participation and Convener of the Black Women's Roundtable; NAACP President and CEO Derrick Johnson and Rev. Al Sharpton, founder and president of the National Action Network, insisted that coronavirus response legisla-

tion must take racial equity into account."

"As we often say, when white America catches a cold, black America gets pneumonia. and never has that metaphor been more apt," Morial said in a statement. "Urban communities of color are likely to suffer the brunt of the health and economic impacts of the corona-

virus crisis and any legislative response must contain targeted relief."

"We're concerned about the impact it will have on children who are out of school and don't have the broadband internet access they need for digital learning at home," Campbell added,

PSC temporarily suspends disconnection of utility services in response to COVID-19

Restriction is in place for 60 days; does not eliminate the requirement that utility customers continue to pay bills

In a special meeting Sunday, March 15, the Mississippi Public Service Commission voted to temporarily suspended disconnections of certain utility services. The restriction will be in place for 60 days and apply to all water, sewer, electricity and gas services.

This action is in response to Governor Tate Reeves's Declaration of a State of Emergency March 14, 2020 regarding the spread of COVID-19. In the declaration, direction was given to examine any statutes. rules or regulations that may be temporarily suspended or modified if those regulations would hinder or delay action necessary to cope with the out-

The PSC coordinated with Mississippi State Department of Health (MSDH) and Mississippi Emergency Management Agency (MEMA) throughout the weekend to implement protocols that ensure all Mississippians have access to essential utility services during the spread of COVID-19.

This is a temporary suspension of disconnection. Utility customers should continue to pay outstanding bills and pay for services provided during the 60 days.

"We are trying to be as proactive as we can and do our part to not only help prevent the spread of the virus, but to not put any additional stress on utility customers and our workforce," Chairman Dane

Maxwell said. "It's very important to us at the PSC to keep our customers and utility partners' welfare a top priority during this time."

"This emergency order will keep vital services connected for our people and protect public health and welfare," Commissioner Brandon Presley for the Northern District said. "We've taken this action at the recommendation of the Health Department and MEMA and we will continue to coordinate any further action with them."

"As we enter uncharted waters, we must sometimes take extraordinary steps to protect consumers, especially our most vulnerable ones, continue commerce and serve the public interest," Commissioner Brent

Bailey for the Central District said. "We don't take the execution of today's action lightly, but the commission felt that it needed to issue this order to protect public health and wel-

The PSC will continue to monitor the outbreak of COV-ID-19 and encourages the public to participate in the measures The Centers for Disease Control and Prevention and the Mississippi Department of Health have outlined in order to prevent transmission of this virus like frequent handwashing, sanitizing commonly touched surfaces, and the ability to remain at home should symptoms develop.

Governor Tate Reeves requests Economic **Disaster Declaration** for small businesses impacted by COVID-19



Maritime Captain Allan Michael, civil rights pioneer, dedicated to ending racism

I want people to know about Allan Michael (1958-2020), who broke new ground as one of the earliest maritime captains of color in New York Harbor, and as the first black captain at New York Circle Line Sightseeing Yachts, in a career spanning 37 years. In one of the busiest port cities in the U.S., as he captained boats with 600 passengers at a time, he never had an accident. And on that fateful day -September 11, 2001 – Michael was among the brave first responders, and used his Circle Line boat from morning to night, to ferry hundreds of terrified people from Ground Zero to safety in New Jersey. His bravery earned him a proclamation of gratitude from the mayor of

Michael will be remembered for his seeing that Aesthetic Realism, the education founded by the great poet and critic Eli Siegel, is the knowledge that can end racism. His study of what Siegel explained is the fight in all people between, contempt - the "addition to self through the lessening of something else," and respect - wanting to know and be fair to the world, was central to his success as a mariner.

In 2017, he gave the keynote speech for the annual Black History Month scholarship dinner of the Organization of Black Maritime Graduates (OBMG). Founded in 1994, OBMG's mission is to advance educational possibilities for African-American and minority students through scholarships, mentoring and forums on contribu-

tions of African Americans to the history of the Maritime Industry. Because of Michael's contributions, he was elected to their board of directors.

He concluded his stirring keynote speech saying:

"It is hard to be black in this country and feel that justice is going to come your way, because black people have endured horrific injustice for years, from slavery to racial profiling. This has made for tremendous anger in our nation."

And speaking about the principles of Aesthetic Realism and what he learned, he continued, "It was through the thought of Eli Siegel, a white man, that I was able to understand the deepest things in myself; and this points to a fundamental hope for all races. In beautiful prose, Mr. Siegel stated: 'It will be found that black and white men have the same goodnesses, the same temptations, and can be criticized in the same way. The skin may be different, but the aorta

is quite the same.' Humanity will thank him as I do for teaching in Aesthetic Realism how all people can honestly see each other with depth, kindness and respect."

Michael's address was greeted enthusiastically. "He kept everyone on the edge of their seat as he told his story," stated the OBMG newsletter. And on his passing this year, OBMG founding board members, Captain Richard Cook and Captain Howard Whyche, wrote a moving tribute to Michael:

"His passion, quiet courage, kind heart and inimitable spirit are a model to be emulated and will be sorely missed. He wrote important articles on how racism can change through the study of Aesthetic Realism. With his wife, educator and public speaker, Monique Michael, he has taken part in nationwide performances of the stirring antiracism production by Alice Bernstein, "The People of Clarendon County" – A play by Ossie Davis, and the Answer to Racism."

This year, Lori Colavito and I had the privilege of attending the February 27, OBMG Black History Month scholarship awards dinner, hosted by the Cultural Club at SUNY Maritime College, where 13 scholarships were awarded. It was deeply moving to hear narratives by young men and women who, in the face of income inequality and racial prejudice, are determined to succeed in the rare career opportunities OBMG offered to them. The response of mentors, students, cadets, teachers and families was joyous.

Stirring tributes were given by cadets to honor deceased mariners: Bahamian Captain Philip Thomas, who perished last September during Hurricane Dorian in the Bahamas; L Antonio Litman, founder of Virginia's House of Hope, providing scholarships to underprivileged youths for maritime careers through their Tugboat Program.

Cadet Claudia Zieba '22 (from Poland) read Captain Michael's official OBMG bio, which tells of his study of Aesthetic Realism.

At the conclusion of the evening, Cadet Joshua Burris, originally from Louisiana, told me, "I want to learn Aesthetic Realism like the captain did."

Small businesses and their employees are the backbone of our state's economy and deserve a helping hand during this trying time. The SBA's Economic Injury Disaster Loan program provides small businesses with working capital loans of up to \$2 million that can provide vital economic support to small businesses to help overcome the temporary loss of revenue they are experiencing.

Each county emergency management agency can provide copies of the SBA Economic Injury Disaster Loan. That paperwork will then be submitted to the Mississippi Emergency Management Agency (MEMA) to hand over to SBA.

That paperwork is to be submitted to MEMA State Coordinating Officer Todd Demuth at *tdemuth@mema.ms.gov*.

"And comprehensive paid family leave for all is needed now more than ever."

"Low-income workers, who are disproportionately African-American, are the least likely to have paid sick leave," said Johnson, NAACP president. "Black workers are more likely to face short-term layoffs or total loss of employment. How is the country going to address their plight?"

Sharpton noted in the release that urban neighborhoods and communities of color often lack access to quality health care facilities.

"What efforts will be made to make testing freely available in urban and poor communities?" Sharpton asked. "We need to make sure that the relief offered in any coronavirus response plan does not bypass the communities most in need."

Trump wants to give money directly to Americans impacted by Coronavirus

President Donald Trump and Treasury Secretary Steven Mnuchin are working on a plan to send checks directly to the nation's citizens to counter the affects of the coronavirus, which has led to the shutdown of businesses in an effort to prevent the spread of the disease. Mnuchin made the announcement during a White House Coronavirus Task Force briefing Tuesday morning.

He did not disclose the amount of the individual checks, but Sen. Mitt Romney (R., Utah) and Sen. Tom Cotton (R., Arkansas) have suggested that each adult receive \$1,000.

Senate Democrats including Cory Booker of New Jersey, Michael Bennett of Colorado and Sherrod Brown of Ohio have suggested sending each American \$4500. Sen. Bernie Sanders, who is seeking the Democratic nomination for president,

has proposed giving each U.S. household \$2000.

U.S. Rep. Ilhan Omar (D., Minnesota) announced a plan to give each adult \$1,000 and each child \$500.

Trump said his administration is working on a "big and bold" legislative package to address coronavirus. Trump said he favored action that would immediately put money in consumers' pockets.

Mnuchin is working on a \$850 billion economic stimulus package

Direct payments to consumers faces stiff opposition from some Republicans.

Lindsey Graham, a Trump loyalist, called direct payments to Americans money wasted. "I don't know if giving a \$1000 on top of their paychecks makes any sense now because there's no economy to participate in. I rather take that money and shore up the health care system," said Graham, a Republican from South Carolina.

Mnuchin warned Republican senators that without government intervention the unemployment rate could reach 20 percent.

This is not a new idea. During the Great Recession, the federal government sent every adult a \$300 to \$600 check, plus \$300 per child. In 2001, the majority of Americans received a \$300 check.

Vicksburg Mayor Flaggs declares a civil emergency

The City of Vicksburg Board of Mayor and Aldermen adopted Flaggs' civil emergency declaration recommendation during a special-called board meeting Wednesday. "This civil emergency declaration will limit the hours worked by non-essential city employees and allow us to use money from our \$3 million reserve fund to respond to the needs of our community," said Flaggs. "Although we haven't had any confirmed cases here in Vicksburg or Warren County up to this point, we're continuing to be proactive and limiting the potential spread of this virus in every way possible."

Forrest General addresses first presumptive positive case of Coronavirus (COVID-19) during press conference



Hattiesburg Mayor Toby Barker urged Pine Belt residents to remain calm and not panic, but to see their primary care physician if they feel they have symptoms of the coronavirus.

The first case of COVID-19 in the state was discussed during a press conference Thursday at Forrest General Hospital. The State Department of Health confirmed Wednesday that a 49-year-old Forrest County male resident had tested positive for the virus.

Rambod Rouhbakhsh, MD, asst. director Forrest General Family Medicine Residency Program, reported this Forrest County resident had traveled

out of the state and began showing signs of fever, cough and muscle aches upon his return to the state. He presented himself for testing at one of Forrest General's clinics. Tests, both nasal and oral, were obtained and submitted to the state lab for testing of the Coronavirus.

Prior to reporting to the clinic, the patient called ahead and was gloved and masked to help prevent the possibility of spread to patients and healthcare workers. The patient was

subsequently sent home for self-quarantine.

Late Wednesday, Forrest General Hospital administration was notified by the state lab that the test was presumptively positive for the Coronavirus and was being sent to the CDC for confirmation.

The patient also traveled with a companion who visited another clinic where the same tests were conducted and submitted.

were conducted and submitted.
"We are currently awaiting those test results," Rouhbakhsh

aid.

"We want to thank this patient for calling in ahead of time before presenting, and we wish him a speedy recovery," Rouhbakhsh said. At this time, the patient is reportedly doing well.

Forrest General has currently sent three samples to the state lab for testing. All three have been negative.

Per the CDC, the symptoms for Coronavirus are fever, cough and shortness of breath. Similarly, typical symptoms of the flu are cough, congestion and fever. For perspective, in 2018, the hospital treated 1,642 flu cases.

"It is far more likely that patients with these symptoms have an illness other than CO-VID-19," said Rouhbakhsh. "Nevertheless we were aware that cases would eventually come to our state. We have been preparing for weeks to be ready to care for our patients. We will get through this.

"We are asking the public to

remain calm. Due to outbreaks overseas and the national attention, supplies for personal protective equipment are in short supply. These are things like masks, gowns and gloves. Due to this short supply, we will be limiting the number of visitors inside our hospitals. Starting today, we will limit one visitor per patient until such time shipment of supplies starts flowing again. We ask for your help during this time of heightened alert."

Forrest Health Hospitals' visitation policies change

'Tragedy and Triumph' and 'March of Remembrance' pay homage to Gibbs-Green

On Feb. 28, the "Tragedy and Triumph: The Lives of the Gibbs-Green Survivors" exhibit opened at the Margaret Walker Center at JSU. The exhibition, which runs through May, is one of several curated events that pay homage to the lives of Phillip Lafayette Gibbs and James Earl Green. The two young men lost their lives, and many were injured, May 15, 1970, when Mississippi police

It is one of the most glazed over tragic events in U.S. history in comparison to the attention garnered by the shootings on the campus of Kent State May 4, the same year.

"The Tragedy and Triumph: The Lives of the Gibbs-Green Survivors exhibit is meant to highlight the men and women who, for the past 50 years, have had to deal with the events of that traumatic night at Jackson State in 1970. But, it isn't meant to look at them as victims. Instead, we want to uplift them and the lives they have led since then," said Robert Luckett, director of the Margaret Walker Center.

Aliyah Veal, a 25-year-old native of Jackson, attended the exhibit opening and shared her thoughts on Gibbs-Green. "Last June, the Margaret Walker Center had a ceremony honoring the victims. I was unaware of what happened, so I think it's important for students and citizens of Jackson in general to know the history and know what happened here and never forget it."

There has been much debate as to why the police converged on the campus the night of May 15, 1970. While it has been challenging to pinpoint a direct source of discord, some say it was several reasons, including protests of the Vietnam War.

Nettie Stowers, retired public relations counselor, was campus sweetheart at Jackson State University in 1970. She said that the year was ripe for protests and discord. "It was a supercharged atmosphere because black men were being recruited and drafted to fight in Vietnam. There was a dis-

proportionate number of black men who died and who served in Vietnam, and a lot of them came out of the college ranks," said Stowers. "That's where the pedal hit the medal for me at Jackson State and many other men and ladies. The black men were being drafted right out of college and being sent straight to Vietnam."

Others say racial tensions were high due to a blatant disregard for the safety of black students at JSU.

In 1964, a JSU student was struck by a white motorist, and her leg was broken. Stowers explained that at that time, Lynch Street ran through the campus of Jackson State University and, many white motorists would not slow down for black students. "So, we were already a little perturbed and upset," she shared.

Whatever the reason, two students lost their lives, and 12 were injured in a night that will forever be ingrained in the hearts and minds of those who witnessed it.

Later in the evening, the JSU Student Government Association hosted a memorial march that led up the Gibbs-Green pedestrian walkway and ended in front of Alexander Hall. A ceremony followed inside the Jacob L. Reddix general purpose room, which included remarks by student leaders Jordan Jefferson, SGA president, Kijana Roberts, JSU NAACP president, Amari Stewart, CAB president, and Eric Brown, president of the National Pan-Hellenic Council. There were also songs by the JSU mass choir and Jordan Scott, and a poem by Jasmine Thomas, a graduate student.

Jefferson, who described May 15, 1970, as a night of gunshots, fear, sadness and tears, also reminded attendees of their role in society.

"It's up to us to make sure that their deaths (Gibbs-Green) are not in vain. So we take up the charge to fight injustice in any form because we are the future of this institution, this city, this state and this nation. It is our responsibility to make this a better place for everyone, regardless of color and race."

Message for faculty, staff from JSU Human Resources

As a part of the JSU Coronavirus Response Team, the Department of Human Resources is providing the following employment guidance and FAQs. These guidelines will be regularly reviewed and updated as this situation unfolds. Although spring break has been extended for students, Jackson State University remains open and all faculty and staff should report for work as normal.

Any employee who has traveled to an impacted Level 3 or Level 2 country, or has been in close contact with a confirmed case of COVID-19, should follow these steps:

Faculty and staff returning from one of these countries must self-quarantine even if no symptoms of illness are present Those individuals must contact the Department of Human Resources at 601 979-2015 to ensure proper designation of leave and receive important information about work arrangements. Please also notify your supervi-

Employees who traveled to an impacted COVID-19 Level 3 or Level 2 country for official university business will be placed on paid administrative leave during the 14-day selfquarantine period. Employees who traveled to an impacted COVID-19 Level 3 or Level 2 country for personal reasons, or who have been in close contact with a confirmed case of COV-ID-19, must use accrued medical or personal leave during the 14-day self-quarantine period.

If a healthcare provider determines an employee has contracted COV1D-19, the employee may become eligible for FMLA leave and any accrued medical leave may be used concurrently with the FMLA leave. Any employee in this circumstance should notify HR so that leave time is properly designated.

At the end of the 14-day quarantine, faculty and staff who are free of symptoms and have followed quarantine procedures should make an appointment with their doctor to be cleared to return to campus. Please call ahead and let the healthcare provider's office know you have been in quarantine. Please send your return to work form to Human Resources for review and determination of when you may come back to campus via fax 601 979-5856 or email hrservices@jsums.edu.

What if I have symptoms of COVID-19?

You should not report to work if you have symptoms (fever of 100.4 F or greater along with cough or shortness of breath). You should report your absence in accordance with your department's call-in procedure. Per our usual leave policies, your first day (8 hours) absent will be personal leave, and then sick leave can be used for additional days needed. If you do not have leave time available, unpaid leave will be approved. For faculty, sick leave may be used on day one.

What if I am sick but unable to get a doctor's appointment or note?

JSU is waiving requirement to provide a doctor's note during this time.

What if I need to take care of a family member who has COVID-19?

If you have sudden caring responsibilities for a family mem-

sence in accordance with your department's call-in procedure. Per our usual leave policies, your first day (8 hours) absent will be personal leave and then sick leave can be used for additional days. If you do not have leave time available, unpaid leave will be approved. For faculty, sick leave may be used on

What if my child's daycare or school closes and I have to stay at home?

If you are unable to work due to caring responsibilities, you should report your absence in accordance with your department's call-in procedure. Per our usual leave policies, personal leave or comp time should be used for these absences. If you do not have leave available, unpaid leave will be approved.

What if I need to self-isolate and can't come to work?

Self-isolation will be condition-specific. For example, if you are required to self-isolate due to exposure, our usual leave policies will apply (first day/8 hours personal leave time then sick leave or unpaid time may be approved if no leave is available). If you plan to personally travel to an area that requires known self-isolation upon return, then you should factor the self-isolation period into your personal leave request. If you are self-isolating by your own decision, then our usual leave policies will apply for requesting time off (personal leave or

What if I, or a family member, am at high risk for the

We encourage you to discuss your situation with your supervisor so that they are aware of your circumstances, can support you appropriately and discuss your personal needs with you as this situation develops. It is likely that the guidance we issue will become role-specific. For example, those who are in roles that have a large amount of face-to-face contact are in a different position than those who work in an isolated way. HR will ask supervisors to work with the individual to agree on how they are best protected. We will address this sympathetically on a case-bycase basis while considering individual circumstances and current guidance from health care officials.

Do I need to complete FMLA paperwork?

We are not requiring FMLA documentation specifically for COVID-19 symptoms. However, if the absence involves hospitalization or longer-term treatment, FMLA paperwork should be requested. For other medical conditions (such as surgery or pregnancy), our FMLA policy will remain

What if it is believed someone is abusing this situation?

We very much hope that this isn't the case, but if you do have concerns please contact Human Resources at hrservices@ jsums.edu.

What should I do if someone is being harassed for their national origin due to CO-VID-19?

The university does not tolerate any forms of discrimination and harassment, so these instances should be addressed immediately. Please contact Human Resources at hrservices@ jsums.edu.



A sea of people.

That's what you saw, overlooking the crowd at the rally you attended. More people, perhaps, than you'd ever seen

in one place before, all gathered together for one ultimate cause. Or were they? In the new book "Hood Feminism" by Mikki Kendall, look again: was that sea of people mostly

Chances are, says Kendall, if it was a women's event, many were. White feminists "can lean in," but they sometimes

don't "show up when black women" have different issues to deal with. Feminism, she says, can't "forget that a movement that claims to be for all women" must "engage with the obstacles women who are not white face."

"And when we act as allies," she says, "feminists have to be willing to listen to and respect those we want to help." That includes understanding that guns have a lot to do with feminism because poor women and women of color are "more likely to be victims of gun violence."

It includes knowing that

hunger and homelessness are painful realities for many black women, and that it doesn't help to make either seem like they were the result of "bad choic-

Respect means that victims of abuse and sexual harassment are not blamed for their clothing, job or hairstyle. It means never asking what they were drinking when they were assaulted. It means the end of hypersexualizing young black girls and women. It means accepting their unique beauty, without politicizing hair or body shape, and without comment. This also, by the way, extends to trans women of any

'Feminism for all' means that we ignore fear and misconceptions of "the hood." It means that we must "unteach the normalization of violence against women." It demands that we confront family and friends who hold racist ideals. It means supporting health measures for women and their children. It means voting for the good of all women, and it requires that allies occasionally "stop, step back and realize they are still part of the problem."

nism," there may come a time when a reader finds it necessary to split the narrative.

On one hand, author Kendall offers exactly what she promises: an uncomfortable truth, because it's necessary and because she's kind, and laying out this information is a sort of kindness. The things she points out are vital for people who profess to be "feminists" to know, and while that may not be any fun, neither is ignorance.



On the other hand, however, Kendall paints white women with a mile-wide, ten-feet-tall brush of condemnation, that may or may not be fair. Yes, these are words that white women need to hear... and yes, they're also somewhat overgeneralized.

Still, keep in mind that this is a book to help, not to censure, and even though it stings, you'll be glad you read it.




