

# "After Medgar, no more fear!"

A Mississippi-produced great organizer, the state's first NAACP field secretary

MEDGAR WI-LEY EVERS, a Native Son, martyred June 12, 1963, gave rise to the phrase: "After


Medgar, no more fear!" The river ran deep in Medgar's

DNA, and he absorbed into his own being his people's living and suffering. He was appalled by the poverty, the destitution surrounding the African-American population in rural Mississippi.

Born in Decatur, Mississippi, in 1925 to James and Jessie Evers, when he was 12 years old, a family friend was lynched and his bloody clothes left hanging on a fence as a sign of intimidation. (Medgar Evers College/CUNY archives 1970)


He joined the army at age 17 and was sent to the European battlefields of World War II. In Europe, he experienced the same racism with segregated field battalions, just as he'd left in Mississippi.

After three years of "distinguished military service," he was

There are at least 3 more cases to go and he says he is innocent. He has even convinced many of his supporters that this is all political. Many of his supporters know he is lying but they still support him this man who shows over and over again his propensity to commit crimes.

As the old song goes, "What Kind of Fool Do You Think I Am?

Let's quickly examine the sycophants and supporters who help to perpetuate this dangerous criminal's success in his politics. So, as human beings perceive reality, we receive raw data, and use cues presented of how to interpret the data. We filter these cues through our values, beliefs, attitudes, paradigms, language, philosophies, that we get from family, education, religion, peers, environments, age, talent, birth order, geography and so on...Then we make assumptions based on this filtering process, resulting in behavior or how we respond to the data. So, many of us do not have the exact same experiences and education so the filtering is different. Simply put, a left-handed person will see a baseball flying toward home plate differently than a righthanded person. Then they react to the pitch. Got it? Now, Criminal thinking styles are used in the criminal justice system to help address how to help a criminal change behavior. To know what to change you must first work to understand the thinking. A scale adapted from the Psychological Inventory of Criminal Thinking Styles, developed by Glenn Walters; Walters (2013), is a standard in understanding the thought processes and crimiCOMMENTARY

nal thinking errors. Examine this sample of the scale which relates to criminal thinking:

· May have a simplistic world view (strong or weak)

• They try to control their surroundings by dominating activities and people, to counteract their feelings of

impotence or powerlessness. · Motivated by immediate gratification and interpersonal control

• External control - (power)

• Internal control (self-discipline); they put themselves in an "up" position and feel better about themselves by putting another person down.

· When people get away with most of their crimes they can engage in a criminal lifestyle for months, sometimes years, before experiencing the negative consequences of their lifestyle. • An attitude of invulnerability develops due to escaping the physical, psychological, and legal consequences of habitual criminality. · They convince themselves that they will escape consequences

honorably discharged and went back to complete his high school education. Afterwards he enrolled at Alcorn College (University), majoring in business administration.

He met his life partner Myrlie Beasley at Alcorn; they married Dec. 24, 1951. Soon they moved to Mound Bayou, Mississippi - a town with the distinction of tracing its origin to freed African Americans coming out of Davis Bend, Mississippi.

The area Davis Bend was started by planter Joseph E. Davis in 1820 – the elder brother of confederate president Jefferson Davis.

The all-black town, Mound Bayou in the Yazoo Delta of Northwest Mississippi, was established in 1887. There were 12 pioneers who survived falling agriculture prices, natural disasters along with hostile race relations. Yet it was a township "promised to African Americans" where the residents showed a love for selfhelp, race pride, looking for economic opportunities and social justice.

Think of this environment feeding into the soul of Medgar. It was a "self-segregated community designed for blacks to have minimum contact with whites until integration was a viable option to black freedom." (https://www. blackpast.org/african-americanhistory/mound-bayou-1887/)

Experiencing this life fed Ed-



gar's discontent which drove him to join the NAACP. While Medgar accomplished much, his true measure is only seen by tallying up the years of "overcoming" and preparation to see his full greatness.

In 2013, the Mississippi State Conference of the NAACP presented "The Life and Legacy of Medgar Evers." This was the 50-year commemoration of the assassination of the "most noted Civil Rights Leader."

The fate that sealed him in our memories occurred June 12, 1963, shortly after midnight when he pulled into his driveway in Jackson, stepped out of his Oldsmobile carrying a package of shirts that read "Jim Crow Must Go."

A sniper's bullet hit Medgar in the back, the only way a coward would shoot a great man. His wife Myrlie rushed out of their house to find her husband bleeding in the driveway. He was taken to University Hospital's emergency room where he died within the hour. He was 37 years old.

Medgar had lived the experiences of several lifetimes and accomplished great feats in courage. He knew and lived with danger; he knew what he was facing. He knew people like the sniper who fired that single shot from a high-powered rifle that kept him "forever young."

Perhaps the great injury was that it took 30 more years - almost the stretch equal to Medgar's lifetime – to bring the Ku Klux Klan member to justice. Remember, there is no statue of limitation on murder.

As the field secretary for the NAACP in the most racist deadly states in the Union – Ground Zero Mississippi – Medgar led boycotts on white-owned businesses that refused service to Black customers. Messing with people's money is always dangerous.

According to the Medgar Evers College (CUNY) archive, Medgar's "organizational skills allowed him to bring together isolated groups of disillusioned individuals and meld them into a unified force."

He held voter registration drives for the state's black residents – knowing that others had been murdered for pushing for equal rights of African Americans. In the Medgar Evers College archives (City University of New York 1970), it is written:

He knew you could be killed in Mississippi simply for "being black" (eg Emmett Till), yet he took on the task and filled the role to represent his people. Myrlie said that Medgar was "constantly aware that he could be killed at any time." Earlier in the year 1963, the Evers home was firebombed. Yet, he continued on the task.

He was in the struggle to overturn segregation of public spaces - no more WHITES ONLY anything. He was a magnet for hostile attention from White supremacists, according to Myrlie moving him up to No. 1 on the "Mississippi to-kill list."

But Medgar openly talked

· However, this only makes their eventual fall that much more dramatic.

• They distort their thinking to deny behavior is selfdestructive and/or harmful.



about why he lived in Mississippi, writing a magazine article to that effect in 1958. He said, "It may sound funny, but I love the South. I don't choose to live anywhere else. There is room here for my children to play and grow and become good citizens – if the white man will let them." (NPR June 12, 2023)

The NPR tribute explained that Medgar applied to law school at the all-white University of Mississippi (Ole Miss) and was denied.

The year before his death, Medgar was instrumental in getting accepted into Ole Miss, James Meredith, who applied in October 1962 and had to be "guarded 24 hours a day by U.S. deputy marshals and army troops. Still a riot of angry white men broke out with two people being killed."

Medgar was remembered in the words of Bob Dylan in tribute at the Newport Folk Festival in 1963, "Only a Pawn in Their Game." Dylan later performed the song at the 1963 March on Washington led by Dr. Martin Luther King Jr.

Dylan's point was "the sniper" was the "pawn;" there were many other guilty hands. His song pointed to and indicted the guilty "system." The sniper was white supremacist Byron de la Beckwith, whose fingerprints were found on a gun at the murder scene.

De la Beckwith was tried by all-white juries twice in the mid-1960s, and both times jurors failed to convict him. "On Feb. 5, 1994, a racially mixed jury found him guilty of the murder of Medgar and sentenced him to life imprisonment where he died of heart failure in 2001.

A decade+1 years later and still our beloved Mississippi native son is unmatched in his organizing skills (there were no computers, no cell phones, no social media). He organized, motivated and activated "the old fashion way" – man-to-man, woman-to-woman, church-to-church and plenty of shoe leather and hours on the clock.


At that 50-year celebration, June 12, 2013, the late Civil Rights activist Vernon Jordan said: "All this change you see in Mississippi is a tribute to Medgar's sacrifice and service and courage and smarts."

The late former Governor of Mississippi William Winter said, "What he (Medgar) did freed us white folks as well as black folks."

Sixty-one years later and we still remember and appreciated how Medgar planned, organized and enacted events aimed at restoring freedom and dignity to all African Americans impacted by Jim Crow laws, racist humiliations and as Medgar's is a testament – murderous rage.

At the 2013 tribute, Medgar's beloved widow Myrlie Evers-Williams closed the tribute simply saying, "We love you, Medgar." We all – as Gov. Winter said, blacks and whites owe Medgar with so much more than we can repay.

So, we too want to say, "We love you Medgar."




Bronze statue of Evers located at Medgar Evers Libraby in Jackson, MS



Evers' poster on display near statue June 2023



# The return of Skinny's

It is a beautiful space at 123 McTyere Avenue in Jackson, Mississippi. The artistic updates happened to the building too fast for Google Maps to keep up with the changes. As of the time of this writing, a new fenced-in patio area was added.

A celebration of its re-opening as a commercial establishment was celebrated on May 25th this year. It was a high energy affair, with live performances on the fenced-in patio area which is the size of a city block.

Skinny's, briefly known as 123 Depot, is open once again under its original name with an artistic flair that is hard to miss. Owner James Bailey says, "It started with him ... " while gesturing toward artist and artistic consultant James "Poke" Hampton. "He got me to see things as an artist. An artist sees things differently. I can't draw it but you see I'm making it. And it's all recycled stuff, like he taught me."

The artistic use of materials that shape the urban eat, drink and be merry spot, known once again as Skinny's, is something that must be experienced to be appreciated. It is a quintessentially Jacksonian eatery located in what is known as the Midtown Arts District, but Skinny's was thriving as a night spot when the Midtown neighborhood was known more commonly as the North End.

In the Midtown Arts District, surrounded by businesses united in the Business Association of Midtown or BAM, Skinny's remains unaffiliated. Ironically, Skinny's stands out as one of the most vibrant and attractive spaces in the district.

Speaking about the grand re-opening, Bailey says, "I have had it like twenty-two years. I am inviting all the people that came here from the time when we were still young to see where we're at now; how it's evolved...it's like a baby, it keeps growing and getting older."

The grand re-opening was also a celebration of the anniversary of the birthday of the eatery's namesake.





The combination of these three chemicals work by super charging our 'pleasure centers' in our brain. Dopamine released during a kiss will stimulate the same area of the brain activated by heroin and cocaine. We will experience feelings of euphoria and addictive behavior. Oxytocin, sometimes called our 'love hormone,' helps to give us a feeling of affection and attachment. Oxytocin is the same hormone that is released Kissing elevates serotonin

during childbirth and breastfeeding.

The levels of serotonin present in our brain when we kiss look a lot like those of someone with Obsessive Compulsive Disorder. Our memory of a good kiss can stay with us for years.

The chemistry of kissing:

Oxytocin: Often called the "love hormone." Oxytocin surges during kissing. It fosters emotional bonding and attachment between partners.

Dopamine: Kissing triggers a release of dopamine, creating feelings of pleasure and reward. It's like a natural high, leaving us craving more.

Serotonin: This neurotransmitter contributes to feelings of happiness and well-being.



### Guilty! Guilty! Guilty! Former President Trump convicted on all 34 felony counts

In a historic and dramatic moment, the jury in New York delivered a resounding verdict Wednesday, finding former President Donald Trump guilty on all 34 felony counts of falsifying business records. This unprecedented decision marks the first time in American history that a former president has been convicted of criminal charges.

A hush fell over the courtroom late in the afternoon as the jury handed Judge Juan M. Merchan a note. "We the jury have a verdict. We would like an extra 30 minutes to fill out the forms if that'd be possible," the note read. The jury had deliberated for 9.5 hours over two days after a three-week trial.

The twice-impeached, fourtimes indicted, and now convicted Trump faced charges connected to a \$130,000 hushmoney payment made to porn star Stormy Daniels in the days leading up to the 2016 election. The trial featured weeks of tawdry testimony about tabloid

deal-making and the alleged sexual encounter between Trump and Daniels. Prosecutors argued that Trump engaged in a fraud against the American people by falsifying records related to the reimbursement of his former lawyer, Michael D. Cohen, who paid Daniels out of his own pocket.

The courtroom was silent as the jury's verdict was read aloud: "Guilty, Guilty, Guilty..." repeated 34 times, solidifying the former president's fate.

Trump, who is the presumptive Republican presidential nominee for 2024, now faces a potential sentence ranging from probation to four years in prison. His legal team has already indicated plans to appeal, a process that could etend over several years.

The conviction has drawn sharp reactions from political figures. Shasti Conrad, chair of the Washington State Democratic Party, declared, "Today's verdict out of New York affirms what the Washington State Democratic Party has been saying for more than eight years – Convicted Felon Donald Trump is wholly un-

fit to lead our nation," Conrad stated. "His conviction today by a jury of his peers demonstrates the lengths Convicted Felon Trump will go to and the laws he will break to get what he wants – another four years of power at the expense of hard-working Americans. The Washington State Democratic Party will never stop fighting for a more perfect union, which is why we will continue to resist Donald Trump's campaign of lies, grift and autocratic desires with every fiber of our being every minute of every day until the election is over and we have prevented the end of democracy...again."

This criminal case is one of four Trump is currently facing, but it is likely the only one that will go to trial before Election Day. Trump faces as much as four years in prison, but because he's viewed as a firsttime offender and the convictions are on low-level felonies, he'll likely receive probation.

"Today, the criminal justice system worked," National Newspaper Publishers Association (NNPA) Chair Bobby Henry stated. "As Dr. Martin Luther King Jr. alluded to, the arc of the moral universe is long, but it bends toward justice," Henry said.

The NNPA is the trade association of the 250 African American-owned newspapers and media companies that comprise the Black Press of America.

### MLB integrates Negro Leagues stats, elevating long-overlooked stars to Major League status



### Rep. Sheila Jackson Lee faces the battle of her life after cancer diagnosis

Major League Baseball (MLB) has taken a historic step to rectify a long-standing oversight by officially incorporating Negro Leagues statistics into its historical record. Starting today, the achievements of approximately 2,300 Negro Leagues players will be recognized alongside those of MLB legends like Babe Ruth and Ty Cobb.

For decades, Babe Ruth and Ty Cobb were celebrated as the greatest figures in baseball, with Ruth hailed as the best player and Cobb as the premier hitter.

However, these narratives often excluded African-American athletes whose contributions were underreported or dismissed. This exclusion persisted despite the talents that led to Jackie Robinson breaking the color barrier in 1947 as the first Black player in the modern Major Leagues.

MLB Commissioner Robert Manfred announced this significant change three years ago, emphasizing the league's commitment to correcting a historical wrong by elevating the Negro Leagues to "Major League" status.

John Thorn, an MLB historian, and the Negro Leagues Statistical Review Committee have been responsible for the meticulous process of officially incorporating Negro Leagues stats into MLB records. The team has been reviewing thousands of box scores and other historical data to integrate the statistics of the seven Negro Leagues into MLB's database.

Josh Gibson, a standout in the Negro Leagues, will now lead multiple batting categories. His career batting average, slugging percentage and OPS surpass those of Ty Cobb and Babe Ruth. While some of Gibson's legendary feats, such as the nearly 800 home runs mentioned on his Hall of Fame plaque, will not be included, many of his official stats will now be recognized.

Thorn hailed the decision as "not only righting a social, cultural and historical wrong, it's defining baseball as a game for Americans without exclusion." He emphasized that baseball is a sport of tradition, but its capacity for profound change is equally significant.

To honor the Negro Leagues, MLB will host a tribute game on June 20 at Rickwood Field in Birmingham, Alabama – the oldest professional baseball park in the U.S. Players will don period uniforms and pay tribute to legendary center fielder Willie Mays, an Alabama native.

With the integration of these statistics, players like Buck Leonard, Buck O'Neil, Cool Papa Bell, Doc Sykes, Monte Irvin, Leroy Satchel Paige and Gibson will finally receive their due recognition. Fans will now appreciate the true scope of their talents and achievements.

Sean Gibson, the greatgrandson of Josh Gibson and executive director of the Josh Gibson Foundation, expressed the family's excitement over this acknowledgment. "We always considered him a major leaguer; he just didn't play in the major leagues," Sean Gibson told NBC Sports. He is eager to see how his great-grandfather's stats compare to those of other MLB legends.

Reflecting on this milestone, he added, "If Josh Gibson was alive right now, he'd be honored. He'll probably wonder why it took so long. He'll be happy for all the other baseball players, and more importantly, he'll be excited for his family to carry on his legacy." Rep. Sheila Jackson Lee has fought tirelessly for groundbreaking legislation throughout her career. She authored the Juneteenth National Independence Day Act, creating the first new federal holiday in nearly four decades, and fervently championed the Violence Against Women Act, ensuring its passage for the first time in almost ten years. Now, the stalwart Texas representative is facing the battle of her life after being diagnosed with pancreatic cancer.

In a statement posted to X Sunday, the 74-year-old congresswoman disclosed her diagnosis and treatment. "My doctors have confirmed pancreatic cancer, and I am currently undergoing treatment," Jackson Lee shared. "I am confident that my doctors have developed the best possible plan to target my specific disease. The road ahead will not be easy, but I stand in faith that God will strengthen me."

Jackson Lee has represented Texas' 18th District in the U.S. House of Representatives since 1995. Now in her 15th term, she serves on the House Committees on the Judiciary, Homeland Security and the Budget, and is the first female Ranking Member of the Judiciary Subcommittee for Crime and Federal Government Surveillance, a subcommittee she chaired during the 117th Congress.

Her legislative achievements are extensive and impactful. Jackson Lee has spearheaded the Sentencing Reform Act, the George Floyd Law Enforcement Trust and Integrity Act, and the RAISE Act. She has also introduced crucial bills like the Fair Chance for Youth Act, the Kimberly Vaughan Firearm Safe Storage Act, and Kaleif's Law. An unwavering advocate for women and children, she fervently supports the Paycheck Fairness Act and the Pregnant Workers Fairness Act and has championed outreach to minority- and women-owned businesses in the commercial space industry. Additionally, she authored the Triple-Negative Breast Cancer Research and Education Act.

Recognized as one of the 50 most effective Members of Congress by 'Congressional Quarterly' and among the ten most influen-

tial legislators in the House by 'U.S. News and World Report,' Jackson Lee's influence extends beyond legislation. She is a founder, member and chair of the Congressional Pakistan Caucus and the Congressional Children's Caucus, as well as chair of the Congressional Black Caucus Energy Braintrust and co-chair of the Justice Reform Task Force.

Educationally, Jackson Lee holds a B.A. in political science from Yale University and a J.D. from the University of Virginia Law School. She is married to Dr. Elwyn Lee, an administrator at the University of Houston. She has two children: Jason Lee, a Harvard graduate, and Erica Lee, a Duke graduate and member of the Harris County School Board. She is also the proud grandmother of twins Ellison Bennett Carter and Roy Lee Carter III.

Despite her diagnosis, Jackson Lee remains resolute in her commitment to her congressional duties. "I am committed to working with our Congressional leadership, including Leader Hakeem Jefferies and the Speaker of the House, to serve this nation and be present for votes on legislation that is critical for the prosperity and security of the American people," she affirmed.

Considering our curchaotic rent political environment, the question that has been on

my mind lately is how should Christians respond to things like the conviction of Donald Trump on 34 felony counts?

It's complicated to some and not as simple as supporting the candidate who uses the bible as a prop, wraps himself in scriptures and shows up at the most churches. shocking behaviors (and unwavering support) are a contemporary example of harvesting bad fruit.



ORDINANCE OF THE CITY COUNCIL OF JACKSON MS CREATING THE SEVERE LIMB AND TREE RISK ORDINANCE TO REMOVE OVERHANGING LIMBS, BRANCHES AND OR TREES THAT CAN AND WILL PRESENT AN IMMEDIATE DANGER ON MUNICIPAL ROADS AND OR STREETS DUE TO STRONG WINDS, HEAVY RAINS AND OR SEVERE STORMS, TORNADO OR ANY OTHER ACT OF GOD.

WHEREAS, the City Council of Jackson, Mississippi acknowledges that there are overhanging limbs, branches and trees, that may present risk and danger during a storm for pedestrians traveling municipal roads and or streets; and

WHEREAS, the City Council of Jackson, Mississippi acknowledges the danger and risk to pedestrians traveling where overhanging limbs, branches and trees exist; and

WHEREAS, it is the aim of the City Council of Jackson, Mississippi to be proactive and to prevent such risks and dangers as loss of life, property, and damages to vehicles, before the outcome of a severe weather threat; and

WHEREAS, the City Council of Jackson, Mississippi acknowledges that strong winds, heavy rain, severe storms, tornados and such other acts of God can cause such limbs. branches, trees to cause damage and harm to pedestrians traveling.

THEREBY, The City council of Jackson creates the Severe Limb and Tree Risk Ordinance as stated.

Section 1 – Assessment

Monthly assessments to be performed by the Public Works department where there is reported, observed or any known risk of the falling and or breaking of limbs, branches and or trees that may present a danger or risk to pedestrians that travel the roads and streets of Jackson, Mississippi where such threat is present.

Section 2 - Findings

Upon the findings of any such threat to pedestrians based on assessment, the Department of Public Works may address and remove such danger on an emergency basis, consistent with the City's emergency procurement procedures

WHEREAS, the City Council of Jackson, Mississippi realizes and acknowledges the importance and preventing accident, loss of life, loss of property, and the obstruction of traffic before such emergency can become fatal.

BE IT HEREBY RESOLVED that the City Council of Jackson, Mississippi creates the "Severe Limb and Tree Risk Ordinance" to protect the health, well-being and safety of pedestrians that may be affected by the falling of a limb, branch and or tree, during strong winds, heavy rains, severe storms, tornadoes, and such other acts of God.

ORDINANCE OF THE CITY OF JACKSON, MISSISSIPPI, CREATING REGULATIONS FOR THE INSTALLATION OF DIGITAL SECURITY CAMERA SYSTEMS FOR PARKING LOT AND ENTRY/EXIT DOOR MONITORING OF CONVENIENCE TYPE GROCERY STORES AND SERVICE STATIONS AND PROVIDING PROCEDURES FOR THE INCORPORATION OF SAID SECURITY CAMERA SYSTEMS INTO THE CITY'S EXISTING BLUE LIGHT CAMERA NETWORK – SAID ORDINANCE TO BE TITLED "CONNECT JXN – BLUE LIGHT SAFETY INITIATIVE".

WHEREAS, the City of Jackson (City) is tasked with protecting the health, welfare, and safety of its residents and visitors by ensuring the availability of crime free and safe convenience stores and gas stations within the City; and

WHEREAS, the City deems it to be in the best interests of the health, safety, and welfare of its citizens, businesses, and visitors to provide safe environments for employees and patrons of convenience stores and gas stations located within the City; and

WHEREAS, the governing authorities of the City find that convenience stores and gas stations' parking lots and fuel pumping areas may expose people to the risk of abductions, robberies, and other similar criminal acts; and

WHEREAS, the governing authorities find that convenience stores and gas stations are often the targets of robberies and/or attempted robberies, many of which occurrences have resulted in the death of a store employee and/or of a store patron; and

WHEREAS, the governing authorities find that insufficient security standards and protocols at convenience stores and gas stations are significant threats to the health, safety, and well-being of citizens and visitors of the City; and

WHEREAS, a study conducted by the United States Department of Justice, Community Oriented Policing Services (COPS), has determined that there is a reduced level of fear amongst people who are aware they are under video surveillance, while also encouraging people to be more security conscious; and

WHEREAS, the above study also concluded that security camera systems may deter criminal activity, especially such activity that takes a longer time to commit, as the potential offender runs a greater risk of capture; and

WHEREAS, video surveillance cameras have proven to be an effective tool for law enforcement officers in the investigations of certain criminal activities and in the apprehension of criminal offenders; and

WHEREAS, the governing authorities find that certain security standards, including the installation of security cameras to monitor the parking lots/fueling areas and entrance/exit doors of convenience stores and gas stations, should both improve the solvability of crimes in those areas and deter and prevent future crimes; and

WHEREAS, the threat posed to the City's citizens, visitors, and business owners by criminal actions occurring at convenience stores and gas stations located in the City is very significant and undermines the City's economic health; and

WHEREAS, by installing security cameras now, rather than after an incident takes place, owners of convenience stores and gas stations will not only protect their patrons and employees, but also help insulate themselves from potential civil liability and potentially incur lower insurance premiums; therefore

NOW BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JACKSON, MISSISSIPPI, AS FOLLOWS:

Section 1. Title. This Ordinance shall be titled "Connect JXN – Blue Light Safety Initiative."

Section 2. Recitals Adopted. The recitals set forth above are incorporated herein by this reference.

Section 3. Definitions. For the purpose of this Ordinance, certain words, phrases, and terms used herein shall be interpreted as stated in this Section. Any word, phrase, or term not defined herein shall be defined as found in the City of Jackson Zoning Ordinance. If a word, phrase, or term is not defined in this Section and not found in the City of Jackson Zoning Ordinance, its ordinary accepted usage applies.

(3.1) Convenience Type Grocery Store (found in Section 202.39 of the City of Jackson's Zoning Ordinance): A store of not more than 3,000 square feet of retail sales area, not counting storage, which deals in grocery items of a convenience nature, and/or the sale of on-site prepared food items. The food items will be sold in edible containers, or in paper, plastic, or other disposable containers for off-premises consumption. This type of use is also commonly referred to as a "drive-in" grocery store with self-service gasoline pumps and may include an automated drive-through car wash.

(3.2) Service Station (found in Section 202.151 of the City of Jackson's Zoning Ordinance): Any building, structure, or land used primarily for the dispensing, sale, or offering for sale at retail of any automotive fuels, oils, accessories, or other sundry items normally sold at service stations for the traveling public, but not including major repair work such as motor overhaul, body and fender repairs, or spray painting.

Section 4. Digital Security Camera Systems in Convenience Type Grocery Stores And Service Stations.

(4.1) Findings. The Jackson City Council finds that requiring the installation of digital security

into the City's "Blue Light Camera Network."

The City Council intends for the owners of convenience type grocery stores and service stations to contact the City's Department of Planning and Development and complete an application and arrange payment for the networking gear that is required for connecting to the "Blue Light Camera Network." This equipment will be installed by the City or its designee. All such businesses should have a date scheduled for installation of the equipment within one hundred and twenty (120) days of passage of this Ordinance.

The City Council intends that the City's Department of Planning and Development will have the authority to enforce compliance with this Ordinance through whatever administrative measures and means that Department deems necessary, including, but not limited to the following: the requirement that convenience type grocery stores and service stations provide proof that they have complied with this Ordinance during their application for a yearly business license; adding the requirement for these security camera systems to the permits that must be obtained during the new construction/remodel of these types of businesses; and the possibility of the imposition of monetary fines for failing to comply.

The City Council intends that the City will provide signage, at no cost to the business, that states that the area is under video surveillance and that the cameras are a part of the City's "Blue Light Camera Network." These signs will be required to be installed in an area that is easily viewable and prominent. Further, as part of the store's payment for the networking equipment, each store will receive an actual blue light device that visually alerts customers and any potential criminal actors that the area is being monitored and that video is being taken and stored.

(4.3) Required Digital Security Camera System for Convenience Type Grocery Stores and Service Stations.

(a) Every convenience type grocery store and service station shall install, maintain, and operate a digital security camera system capable of connecting to the internet that produces easily retrievable digital video files that are of such quality as to make the distinguishing characteristics of patrons and vehicles easily identifiable, whether recorded during the day or at night, and storing them in such a way as to allow for the uploading of the video footage to the "Blue Light Camera Network's" cloud storage. For purposes of compliance with this ordinance, this requirement is the duty and obligation of the developer, owner, and/or lessor of the real property on which the convenience store and/or service station is located.

(b) The digital security camera system must be capable of identifying and distinguishing all vehicles entering and leaving the parking area/lot(s), identifying all vehicles making use of gasoline fuel pumps, and identifying all individuals entering and exiting the establishment. This will require the installation of a minimum of two digital security cameras covering the parking lot/fuel pumps and the entry/exit of the business.

(c) Specifications of the digital security camera system shall be:

(1) Camera: Digital cameras must be able to produce videos and images capable of identifying and distinguishing all vehicles entering and leaving the parking area/lot(s), identifying all vehicles making use of gasoline fuel pumps, and identifying all individuals entering and exiting the establishment, whether recorded during the day or at night.

(2) Video Resolution: All video recordings must have a resolution that is sufficient for identifying and distinguishing all vehicles entering and leaving the parking area/lot(s), identifying all vehicles making use of gasoline fuel pumps, and identifying all individuals entering and exiting the establishment, whether recorded during the day or at night.

(3) Recording Capability: All videos must be stored in such a way that they can be quickly uploaded to the "Blue Light Camera Network's" cloud storage. After the video files have been uploaded to cloud storage, business owners are then free to delete any video files still stored on their local security camera system.

(d) Recording Duration: every convenience type grocery store and service station covered by this ordinance shall operate its digital security camera system twenty-four hours per day.

(4.4) Implementation Schedule. Every convenience type grocery store and service station covered by this ordinance shall have a compliant digital security camera system installed and a date scheduled for the City, or its designee, to install the required networking equipment within one hundred and twenty (120) days of passage of this Ordinance. However, the imposition of any monetary fines and/or other penalties that might be created by the City's Department of Planning and Development for failing to comply with this Ordinance shall not begin being assessed until January 1st of 2025. Convenience type grocery stores and service stations covered by this Ordinance that begin operations after the effective date of this ordinance shall comply with the requirements of this ordinance prior to the commencement of operations and shall comply with any and all requirements established by the City's Department of Planning and Development.

(4.5) Signage Requirement. Every convenience type grocery store and service station covered by this ordinance will be provided with a sign from the City that gives notice that the area is under twenty-four-hour video monitoring and gives notice that the security cameras are connected to the City's "Blue Light Camera Network." This sign shall be posted in an area that is clearly visible and prominent.

(4.6) Permitting Fees Waived. The City shall waive all building permit fees associated with the initial implementation of this ordinance upon the permitting and installation of a complaint digital security camera system connected to the City's "Blue Light Camera Network."

(4.7) Exceptions. It shall not be a violation of this Ordinance if the security camera system is inoperable because of an act of God, including, but not limited to, weather conditions, if the security camera system is restored to operational capacity as soon as is reasonably possible.

#### LEGAL

#### ORDINANCE PROHIBITING BLOCKED RAILROAD CROSSINGS IN THE CITYOF JACKSON, MISSISSIPPI.

WHEREAS, the City of Jackson, Mississippi, recognizes the serious safety hazards posed by blocked railroad crossings, including the potential for frustrated individuals to attempt dangerous maneuvers between stopped railcars and hindrance to emergency services' access to individuals and hospitals; and

WHEREAS, the federal railroad administration acknowledges the authority of local communities to address the issue of blocked crossings through regulations at the state or local level; and

WHEREAS, it is imperative for the city council of Jackson, Mississippi, to take proactive measures to ensure the safety and well-being of its residents and visitors;

NOW, therefore, be it ordained by the City Council of Jackson, Mississippi:

#### SECTION 1: DEFINITIONS

Blocked Railroad Crossing: any instance where a stationary train impedes the flow of motor vehicle or pedestrian traffic at a railroad crossing for a duration exceeding 5 minutes.

Section 2: Prohibition of Blocked Railroad Crossings

It shall be unlawful for any railroad conductor or operator to permit a blocked railroad crossing within the city limits of Jackson, Mississippi, for a duration exceeding 5 minutes, except in cases of emergency or operational necessity, as actively determined by Jackson Police Department, Jackson Fire department, and the Department of Public Works.

#### Section 3: Movement of Transitioning Trains

Trains transitioning from stationary status shall move no less than 100 feet before becoming stationary again, unless circumstances beyond the control of the railroad company or operator necessitate a shorter distance, as actively determined by Jackson Police Department, Jackson Fire Department, and the Department of Public Works.

Railroad conductors or operators shall immediately contact the Jackson's chief of police, fire chief, and public works director (or appointee) to notify each of the necessity transition the train to stationary status longer than 5 minutes.

#### Section 4: Penalties for Violation

Any railroad conductor or operator found to be in violation of this ordinance shall be subject to arrest and incarceration for a period of 15 consecutive days.

Additionally, violators shall be fined \$1,000 for each occurrence of a blocked railroad crossing exceeding the prescribed time limit.

#### Section 4: Enforcement

The Jackson Police Department and other relevant city authorities are hereby authorized to enforce the provisions of this ordinance.

Upon receiving a report of a blocked railroad crossing, law enforcement officers shall promptly respond to the scene and take appropriate action to ensure compliance with this ordinance.

#### Section 5: Notification requirements

Railroad companies or operators shall be required to promptly notify the Jackson Police Department, Jackson Fire Department, and the Department of Public Works in the event of a blocked railroad crossing lasting longer than 5 minutes.

#### Section 6: Severability

If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the ordinance that can be given effect without the invalid provision or application, and to this end, the provisions of this ordinance are declared to be severable.

#### Section 7: Effective Date

This ordinance shall take effect immediately after its passage and publication as required by law.

#### Section 8: Repeal of Conflicting Ordinances

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

cameras to monitor convenience type grocery stores and service stations' fueling areas/parking lots and entranceways/exits to be in the best interests of the City of Jackson in that it will help protect the City's citizens, visitors, and business employees from abductions, robberies, and other similar criminal acts and will assist local authorities in the apprehension of the perpetrators of such crimes. The City Council also finds that the requirement of the installation of a digital security camera system is not unreasonable or overly burdensome for local business owners, as most convenience type grocery stores and service stations already have functioning digital security camera systems.

The City Council further finds that the installation and use of such digital cameras will act as a deterrent to future crimes. Further, the requirement that said digital security camera systems be connected to the City's "Blue Light Camera Network" will aid in protecting the health and safety of the City's citizens, visitors, and business employees by bolstering the Jackson Police Department's ability to respond to emergency situations quickly and safely by having access to real-time video footage of the location. Further, the "Blue Light Camera Network" ensures that video footage is stored safely encrypted in the "cloud" and will be easily accessible and quickly retrievable so that the City is able to investigate and more quickly and safely apprehend criminal suspects.

The City Council finds that such a system will also have the effect of greatly reducing police department labor-hours, thereby allowing those city funds to be spent elsewhere on things such as hiring new police officers and purchasing new equipment, that have been traditionally spent, after a crime has been committed at such a business, in contacting these businesses and attempting to coordinate a time to travel to the business to gain access to the camera system for the search and retrieval of video footage.

Finally, the City Council finds that this digital camera security system requirement will also greatly benefit the owners of convenience type grocery stores and service stations by increasing the number of customers, by assisting with lowering the number of people loitering on the premises, by protecting the business's employees, by greatly reducing the business's possible exposure to civil liability, and by possibly lowering liability insurance premiums.

(4.2) Intent. It is the City Council's intent to require all convenience type grocery stores and service stations located within the City of Jackon to install and properly maintain a digital security camera system that, at a minimum, provides video coverage of the fueling area/parking lot and the entry/exit to the building using a separate digital camera to cover each location. The digital cameras and resulting video footage should be of such a quality to enable the identification and distinguishing characteristics of people and vehicles located on the premises.

Convenience type grocery store and service station owners are required to purchase and install these digital security cameras and/or to ensure that the already existing digital security cameras can connect to the internet and that they meet the minimum requirements of this Ordinance (such as image quality requirements and location requirements).

The City Council further intends that all such digital security camera systems that are to be installed pursuant to this Ordinance (and all such digital security camera systems that have already been installed that meet the minimum requirements of this Ordinance) be incorporated

Section 5. Penalties. The City's Department of Planning and Development shall be responsible for creating and enforcing any monetary and/or other penalties associated with failing to comply with this Ordinance. Any such penalties shall be published and made available to the public. All penalties created pursuant to this Ordinance shall be subject to an appeal and any and all persons/entities penalized under this Ordinance shall have the absolute right to an appeal. The City's Department of Planning and Development shall be responsible for establishing these appeal procedures.

Section 6. Severability. The provisions of this Ordinance are declared to be severable, and if any section, sentence, clause, or phrase of this ordinance shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this ordinance but they shall remain in effect, it being the legislative intent that this ordinance shall stand notwithstanding the invalidity of any part. Specifically, should the requirement that all security cameras covered under this Ordinance be connected to the City's "Blue Light Camera Network" be found to be in violation of state and/ or federal rules, laws, or regulations, or be found to violate either the Mississippi Constitution or the United States Constitution, it is the legislative intent that said requirement be stricken from this Ordinance without affecting the validity of the remaining sections, sentences, clauses, and phrases of this Ordinance.

Section 7. Conflicts. All Ordinances in conflict with this Ordinance are repealed only to the extent of such conflict.

Section 8. Effective Date. This ordinance shall be effective thirty (30) days from and after adoption.
